Old Business

The Town Attorney was present to answer legal questions on the East Side Road of Lake George and the Town appointees to the Lake George Board.

99% of all roads are owned by the State, Towns will vote to accept roads to maintain and a Town Way Public Easement. Absent a deed given to the town form the land owners the towns do not own a road.

The town owns a right of passage. The Town controls the town access of the way and can control parking bans, speed limits, etc. The Town needs to maintain a safe way on the road.

To discontinue a road the Town would have to vote. If the citizens decided to discontinue the road it would be given back to the State.

Possible things to happen.

- 1) A Parking Ordinance
- 2) Town needs to find out the rod width of the road
- 3) Make a memorandum with Lake George and bring it to the State

Jeff Clarke motioned to meet with Lake George to create a memorandum. Motion was not passed.

Jeff Clarke motioned to clarify the road and Parking with the State, seconded by Megan Smith.
